Chairman Galvin called the meeting to order.

The Chairman announced that the Meeting was being held in conformance with the Open Public Meetings Act of 1975 and that adequate notice has been duly posted where required and mailed to the Asbury Park Press and the Coaster in accordance with the law.

2019 CONNECTION FEE HEARING

Attorney Bonello opened the Connection Fee Hearing and provided a list of the documents presented to support the adoption of the new fees. Mr. Bonello swore in Auditor David A. Kaplan who provided a statement as to his credentials as well as an explanation of the criteria used to determine the new fees.

18 - 102 ESTABLISHING CONNECTION FEE EFFECTIVE JANUARY 1, 2019

WHEREAS, The Township of Ocean Sewerage Authority published Notice of proposed adjustments of its Rate Schedule and of the time and place of the public hearing thereon in two newspapers of general circulation in the area serviced by the Authority at least twenty (20) days preceding the aforesaid public hearing; and

WHEREAS, the Authority conducted a public hearing on the proposed adjustments of its Rate Schedule on Tuesday, December 4, 2018 at 6:30 p.m. at the offices of the Authority as indicated in the publication of Notice; and

WHEREAS, the Authority provided evidence at the hearing showing that the proposed adjustments of its Rate Schedule are necessary and reasonable; and

WHEREAS, the Authority provided the opportunity for cross-examination of persons offering such evidence at the public hearing; and

WHEREAS, the Authority ordered that a transcript of the hearing be made and a copy thereof be available upon request to any interested party at a reasonable fee; and

WHEREAS, the Authority has considered the proposed adjustments to its Rate Schedule, as well as all evidence presented through direct and cross-examination, as well as all comments made by those members of the public in attendance at the aforesaid public hearing, as well as any written comments that may have been received; and

WHEREAS, the Authority having been satisfied from all of the evidence and comments presented that the proposed adjustments of the Rate Schedule are in accordance with the Statute and are reasonable and necessary.

NOW, THEREFORE, BE IT RESOLVED on this 4th day of December 20178 that the proposed adjustments to the Rate Schedule attached to this Resolution be and the same are hereby approved and adopted by the Authority; and

BE IT FURTHER RESOLVED that the revised Rate Schedule shall become effective on January 1, 2019; and

BE IT FURTHER RESOLVED that the provisions of The Township of Ocean Sewerage Authority Rules and Regulations pertaining to the payment of such charges and to the time or times when and the place or places where such charges shall be due and payable, be and the same are hereby incorporated herein by reference; and

BE IT FURTHER RESOLVED that a copy of the Rate Schedule in effect shall at all times be kept on file at the office of the Authority and shall at all reasonable times be open to public inspection

WHEREAS, the Annual Budget and Capital Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

WHEREAS, the Annual Budget, as presented for adoption, reflects Total Revenues of \$7,329,221, Total Appropriations, including any Accumulated Deficit, of \$7,329,221 and Total Unreserved Net Position utilized of \$0.00; and

Operations Manager Report December 2018

Plant:

New sodium hypochlorite tanks were installed for the chlorine tank system.

Bar screen repairs were started before Thanksgiving and will be completed in December. Greely and Hanson sampling portion of model programing has been completed.

Dan DeSoucey has been working on both the Lucity computer system and WiFI system for the plant.

Plant seemed to hold up well with the back-to-back storms we had this month.

Bio-Air has been in several times during the month monitoring the new odor control unit.

Collections:

Cleaned all pump stations.

Jet and vacuumed all bad area in town for maintenance.

Started TV inspections of the North Edgemere Dr. area. Found some issues with manholes and will address them after the inspection is completed in the West Allenhurst section.

Operations:

Asbury Park Fire Department completed their annual drill on November 27. This was done at the Whalepond Pump Station. We will schedule for next years in the spring at a station on the west side of town.

Sky Morehouse was in on November 16 and we discussed the pump station alarm issues. I have started ordering the supplies he requested now in order to complete the upgrade on the computer system.

We received our new 6" trash pump.

AUTHORIZING PERMANENT ADJUSTMENTS TO CERTAIN COMMERCIAL ACCOUNTS

WHEREAS, Kane Brewing Company operates at 1750 Bloomsbury Avenue, sewer account number 18828-1; and

WHEREAS, Kane Brewing Company estimates that fifty percent (50%) of the water consumption results in finished product or is absorbed and retained in malted barley during the brewing process; and

WHEREAS, an article in the December 2012 WE&T magazine states that craft brews consume an average of 5 to 6 gallons of water for every gallon of beer produced; and

WHEREAS, commercial account numbers 18538 -0 and 18718-0 have received annual water usage adjustments as a result of sprinkler systems, which resulted in zero excess usage.

NOW, THEREFORE, BE IT RESOLVED that the Township of Ocean Sewerage Authority hereby authorizes that the annual water usage for account number 18828-1 be reduced to seventy percent (70%) of the annual water usage for purposes of determining an annual excess usage charge; and

BE IT FURTHER RESOLVED account number 18538-0 be flat-billed for one (1) unit and account number 18718-0 be flat-billed for two (2) units; and

BE IT FURTHER RESOLVED that the Authority reserves the right to charge excess water usage for these accounts should the circumstances giving rise to this Resolution change in the future.

ESTABLISHING PROJECTED FLOW CRITERIA FOR CONNECTION FEE PURPOSES

WHEREAS, the rate schedule of the Township of Ocean Sewerage Authority provides that sewer connection fees for non-residential uses are to be based on the projected flow from the unit; and

WHEREAS, the Authority has determined to use the projected flow criteria contained in N.J.A.C. 7:14A-23.3 in determining the projected flow from non-residential uses, whenever practicable, as a basis for determining projected flow; and

WHEREAS, N.J.A.C. 7:14A-23.3(a) provides that the criteria contained therein is not mandated to be used as a basis for establishing connection fees; and

WHEREAS, the projected flow criteria contained in N.J.A.C. 7:14A-23.3 either do not address certain uses, or contain flow projections that have been determined by the Authority to be inconsistent with actual flows; and

WHEREAS, the Authority intends to specify projected flows for the uses that are not addressed by N.J.A.C. 7:14A-23.3, and for uses that have been determined by the Authority to be inconsistent with actual flows, in order to provide a uniform basis for determining projected flows and connection fees within the Township of Ocean.

NOW, THEREFORE, BE IT RESOLVED by the Township of Ocean Sewerage Authority as follows:

- 1. The projected flow criteria contained in N.J.A.C. 7:14A-23.3 shall be used by the Authority in determining projected sewage flows for non-residential uses, whenever practicable, unless exceptions to the criteria are adopted by the Authority.
- 2. In the event that a type of use is not listed in N.J.A.C. 7:14A-23.3, the Authority shall use its best judgment in determining the criteria for projected sewage flow.
- 3. For the purpose of determining projected sewage flow, any reference to "seat" or "person" in this Resolution or in N.J.A.C. 7:14A-23.3 shall be deemed to mean the maximum permitted occupancy established pursuant to the Uniform Construction Code and/or the Uniform Fire Code.
- 4. The following projected sewage flow criteria is hereby adopted by the Authority as additions or exceptions to those contained in N.J.A.C. 7:14A-23.3 and added to those additions or exceptions set forth in Resolution 11-27 adopted April 5, 2011:

- 5. Sewage connection fees for all non-residential uses shall be subject to the minimum sewer connection fee established for single-family residential unit pursuant to the current rate schedule
- 6. This Resolution supersedes all prior resolutions establishing projected flow criteria and is effective immediately.

18 – 107 AUTHORIZING PURCHASE OF GODWIN BYPASS PUMP FROM XYLEM UNDER STATE CONTRACT NUMBER A85374

WHEREAS, the Authority is desirous of purchasing a bypass pump and accessories for use its pump stations; and

WHEREAS, the Authority has a Qualified Purchasing Agent; and

WHEREAS, Xylem has a State contract for a Godwin Bypass Pump under State contract number A85374 for the price of \$35,896.00; and

WHEREAS, certain accessories totaling \$8,760.14 are required to make the Bypass Pump operational at all the Authority's pump stations; and

WHEREAS, the Authority's Executive Director has certified that funds are available for this contract in GL line items Bypass Connections (01-500-00-009), Pump Replacements (01-500-00-025) and Collection System Improvements (01-500-00-23).

NOW, THEREFORE, BE IT RESOLVED that the Township of Ocean Sewerage Authority hereby authorizes the purchase of a Godwin Bypass Pump from Xylem under State contract number A85374 with accessories for a total purchase price with delivery of \$44,906.41.

AUTHORIZING PAYMENT IN THE AMOUNT OF \$30,380.00 TO WEEKS MARINE INC. FOR OCEAN OUTFALL REPLACEMENT PROJECT

WHEREAS, the Authority awarded a contract for its Ocean Outfall Replacement Project to Weeks Marine Inc. in the amount of \$5,324,150.00 (the "Project") on September 8, 2018; and

WHEREAS, the Weeks Marine requested payment for Pay Item No. 2 (Performance and Payment Guaranty Insurance); and

WHEREAS, by letter dated November 29, 2018 the Authority's engineer has recommended payment in the amount of \$30,380.00 pursuant to its Payment Application No. 1.

THEREFORE, BE IT RESOLVED that the Township of Ocean Sewerage Authority hereby approves payment in the amount of \$30,380.00 to Weeks Marine Inc. for the Ocean Outfall Replacement Project in accordance with Payment Application No. 1.

AUTHORIZING PAYMENT IN THE AMOUNT OF \$86,638.86 TO LUCAS CONSTRUCTION GROUP, INC. FOR 2013 COLLECTION SYSTEM UPGRADES PROJECT
