A meeting of the Township of Ocean Sewerage Authority was held on the above date at the Authority Administration Building, 224 Roosevelt Avenue, Oakhurst, New Jersey.

Chairman Galvin called the meeting to order.

All recited *The Pledge of Allegiance*.

Chairman Galvin announced that the Meeting was being held in conformance with the Open Public Meetings Act of 1975 and that adequate notice had been duly posted where required and mailed to the *Asbury Park Press* and *The New Coaster* in accordance with law.

WORK SESSION

<u>Attorneys</u> Report. Attorney Bonello was absent from the meeting. Chairman Galvin noted that Mr. Bonello had received the check from Asbury Park for their share of the cost of an analysis of TOSA's treatment plant capacity.

<u>Engineer's Report.</u> Mr. Schreiber reported that Blackrock Enterprises started the last run of pipe for the Wickapecko Drive project.

<u>Superintendent's Report.</u> Mr. Meholic gave a review of his report. He advised that he spoke with a representative with regard to the bio filter that is used for odor control. The representative indicated that he would prepare a cost analysis of the use of a wet scrubber compared to another type of unit (Evoqua Zebocs), which would provide significant cost savings.

<u>Executive Director's Report.</u> Due to Mr. Schmeling's absence, Chairman Galvin provided a review of the Director's written report.

The Chairman also gave a review of the resolutions on the agenda.

BUSINESS SESSION

Mr. Theodora offered a motion, seconded by Mr. Stubbs and unanimously carried to approve the minutes of the following meeting:

Regular Meeting

A copy of the Plant Operator's Report for the month of November was received, a copy of which follows:

The November 2016 report shows the treatment plant and collection systems O.K. with some repairs to report.

The average daily flow to date was 3.122 MGD. The highest daily flow was 3.507 MGD on November 14th. The total precipitation to date was 4.42 inches for the month; the largest precipitation was 1.45 inches on November 15th. Central New Jersey remains in a rainfall deficit.

The monthly average effluent suspended solids concentrations, to date 4 mg/l and for CBOD, the concentration was 3 mg/l. The average percentage removals for these same effluent parameters were 98% and 97% respectively. Our present NJPDES Permit has a suspended solids monthly average limitation of 30 mg/l and 25 mg/l for CBOD. For percent removals, it requires 85% removals on a monthly average basis for suspended solids and for CBOD. For plant flow, we are permitted 7.5 MGD average daily flow on a 30-day average quantity basis.

PLANT OPERATIONS AND MAINTENANCE

The treatment plant is operating OK with some maintenance to report.

Glen Henry and AJ Milmoe performed repair and preventative maintenance in the following locations: they performed routine maintenance on the UNOX System.

Bruce Olsen replaced street lighting in the administration building parking lot. Genserve Inc. was in to replace a belt on the Unox Building Emergency Generator. Pumping Services Inc was in to install the Main Pump No. 3 and make all connections. All main pumps are back in service.

Scott Stedman and Rich Roman drained, cleaned and inspected final clarifier 4. Rag/wipes debris was removed from some of the RAS suction piping.

Mark Woszczak has ordered materials for the RAS sludge line replacement still waiting for their delivery.

Scott Stedman, Rich Roman, in D'Esposito, Glen Henry and I all assisted Hazen and Pure Technologies with the Outfall Study. We were draining and filling the wet well and final clarifier 3 for required downtime for the Pipe Diver insertion. Unofficially the land-based pipe seems ok for the most part upon the initial fieldwork; however they saw some issues with the 1968 section of ocean based pipe.

After the Outfall Repair Study we had Burke Construction replace our beach manhole cover with a locking watertight manhole cover. Then they backfilled the work area.

US Army Corps of Engineers were very cooperative and TNJ Marine was successful with their work. Hazen was on site throughout the entire week. Overall the project was a success and the Pure Technology team was confident that their study data should be complete and accurate.

The activated sludge and Enterococci levels have been stable. I am giving Bill Schmeling a separate memo requesting the services of Hall Associates to make formal application for a NJPDES Permit stay for our Enterococci permit reporting.

I am investigating a different bio filter than what we discussed, regarding Mt. Holly MUA.We have an offer for a full-scale trial demo unit of an Evoqua Zabocs unit. It has a glass media that will not break down. The nutrient chemical cost is roughly \$15,000-20,000 / year. This is app. 20% of the cost of operating the traditional chemical wet - sodium hypochlorite scrubber (Greeley and Hansen Odor Control Study reference). I am waiting on a proposal and other particulars to iron out the logistics of set up and potential purchase cost. We have begun rinsing the existing bio filter woodchips in order to raise the pH; so proper disposal can take place.

COLLECTION SYSTEM OPERATION AND MAINTENANCE

The collection system had the following work to report:

All routine pump station inspection and maintenance work was completed by Tom DiOrio, Ken Williamson, Rich Roman, and Vinnie D'Esposito.

At Interlaken PS we had a leak in Bioxide feed tubing that was replaced. Evoqua came in to inspect and service all Bioxide systems at all seven pump station installations. At Norwood PS we unclogged a flush valve and reinstalled the rebuilt unit.

We responded to a grease blockage on Ring Road, downstream from Costco Inc. We also responded to a blockage at 487 Edgemere Pl. We also checked two lateral problems at 35 Peachtree, 488 Monmouth Rd. and 1009 Grassmere, which were the homeowners' laterals and their responsibility. We also responded to a homeowner at 83 Wickapecko Dr. who while doing his own plumbing reconnected a new lateral to his abandoned inactive septic tank piping. We offered assistance in troubleshooting the piping layout.

Mark Woszczak replaced a lateral at 1109 Grassmere Ave. It was originally repaired using a Fernco Coupling but the line developed bad sag and was a source of several blockages.

Vacuum /jetting work for the month took place at Grassmere Ave., 1105 Bendermere Ave. Ken Williamson met with Black Rock Construction who is currently replacing the water line and some of the sewer line at Wickapecko and S. Wanamassa Dr.

The CCTV inspection camera was returned to service. We performed CCTV inspection work this month at the following locations:

Walnut Ave. 152ft., Chestnut Ave. 325 ft., Spruce Ave. 290 ft. and Maple 460 ft.
